Ident-check	Delivery of the goods exclusively to the intended recipient after successful identity check with the ID document presented. Optional check of a minimum age	€ 2.99

Visual check of age	Delivery to a person authorized to receive items pursuant to section 4 par. 2 and 3 of the GT&C Paket/Express National only after checking the minimum age (≥16 or ≥ 18) which in case of doubt has to be proved by means of an official photo document (e.g. identity card, passport or driving license)	€ 1.19
Delivery day	Specification of the delivery date in advance. Parcel must be posted at least two and no more than six business days before the desired delivery date. The requested day may only be a business day (Mon-Sat)	€ 0.99

Signed for by Recipient	Delivery against signature of the recipient or a substitute recipient	€ 0.19
