# PERMISSIBLE CONTENTS FOR DOMESTIC AND INTERNATIONAL PARCEL ITEMS AND FOR DOMESTIC EXPRESS ITEMS (VALUABLES PROVISION FOR PARCEL/EXPRESS)

## 1. Scope of application

(1) As a supplement to the restrictions for higher-value goods (so-called valuables) in the respective applicable General Terms and Conditions of DHL (GT&Cs), the following provisions ("Valuables Provision for Parcel/Express") apply for the following services:

- DHL Paket (domestic)
- Express shipments (domestic)
- DHL Paket International
- DHL Paket Connect

(2) The Valuables Provision for Parcel/Express does not apply to international Express shipments and DHL Europaket.

(3) The Valuables Provision for Parcel/Express applies regardless of whether transport insurance has been taken out by DHL and/or the sender for the respective shipments.

### 2. Restrictions to sending items of value

(1) Sending goods with a value exceeding €25,000 per parcel and/or Express shipment (per piece) is not permitted.

(2) Irrespective of (1), sending certain high-value goods (so-called class II valuables) whose value exceeds €500 per piece is not permitted.

For domestic parcel and Express shipments, all class II valuables for shipments from the same sender to the same recipient are limited to €500 per day, even if multiple shipments from the same sender are sent to the same recipient on the same day.

(3) Class II valuables are the following goods:

# 1. Securities

That is, money-equivalent instruments honored by banks that can neither be blocked nor rendered worthless or replaced if damaged, and that can easily be transferred to third parties (e.g. without identification such as serial numbers), for example:

- Road tax vignettes
- Dividend certificates (incl. canceled certificates)
- Admission tickets and travel tickets (transferable)
- Profit participation certificates
- Valid postage stamps (German and foreign)
- Vouchers, coupons (incl. canceled vouchers and coupons)
- Checks with guaranteed cashing and blank traveler's checks
- Tax stamps, interest coupons (incl. canceled tax stamps and interest coupons)

# 2. Other valuable items

- Other means of payment
- Cash, i.e. valid coins and paper money (German and foreign)
- Precious metals\* (new, used or defective), e.g. gold, silver or platinum in the form of bars, gold nuggets, gold and silver coins
- Gemstones
- Works of art, paintings, antiques, one-of-a-kind items and other precious objects (e.g. items with value to collectors such as stamps, coins or figurines)
- Pay TV cards
- Jewelry (e.g. made from pearls, corals or amber)
- Watches, except wearables (e.g. smartwatches)
- Processed dental gold

(4) In deviation from (2), the following class II valuables are permissible up to a value of €25,000 for shipment with DHL Paket International (not with DHL Paket Connect):

- Gemstones
- Works of art, paintings, antiques, one-of-a-kind items and other precious objects (e.g. items with value to collectors such as stamps, coins or figurines)
- Jewelry (e.g. made from pearls, corals or amber)
- Watches

(5) When sending class II valuables together along with other (high-value) items in a single parcel and/or in one Express shipment, the maximum value of €25,000 in total may not be exceeded.

The value of the class II valuables contained therein may not exceed €500 in total; (4) remains unaffected.
